
ARTICLE I: The name of the Limited Liability Company is: **Oaks Family LLC**

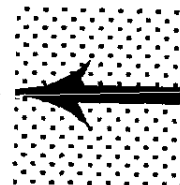
