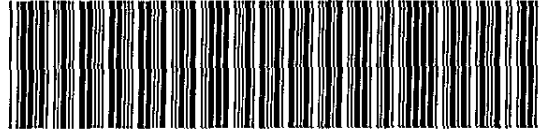

ARTICLES OF ORGANIZATION  
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be:

ARTICLE III - PURPOSE AND POWER

The business of the Company shall be to carry on any lawful business or activity in accordance with applicable law, and to have and exercise all of the power, rights and privileges which a limited liability company organized pursuant to the Florida Act may have and exercise. In carrying out the purpose of the Company, but subject to all other provisions of this Agreement, the Company shall have all powers and rights of a limited liability company organized under the Florida Act; to the extent such powers and rights are not proscribed by the Articles. There will be two (2) individual owners of the Company Ric DeMay having 60% and Frank DiNardo having 40% interest. In the event of the death of one of the owners the survivor will have 100% of the entire company.

ARTICLE VII – DISTRIBUTION OF FUNDS


Any payments made will be distributed equally among the two owners. No management fees or any other fees will be taken out of this LLC without the approval of each owner.
