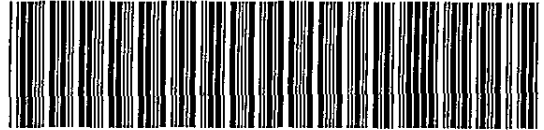



ARTICLES ORGANIZATION FOR FLORIDA LIMITED LIABILITY COMPANY

ARTICLES I - Name:

The name of the Limited Liability Company is Tropical Rootz LLC.

ARTICLE II - Address:

The mailing address and the street address of the principal office of the limited liability company

No amendment or repeal of this article, nor the adoption of any provision to these Articles of Organization inconsistent with this article, nor the adoption of any provision to these Articles of Organization inconsistent with this article, shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal or adoption.
