ARTICLE VIII - MANAGEMENT


The Company shall be managed by its Managing Members, subject to the provisions of the Operating Agreement.

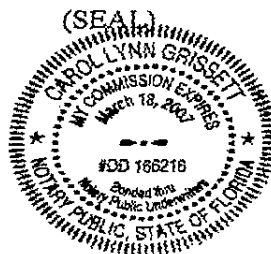


