

ARTICLE VIII - MANAGEMENT

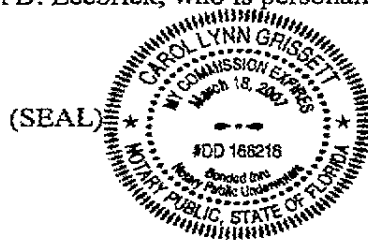
