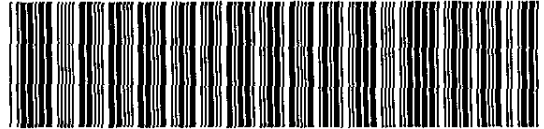

ARTICLES OF ORGANIZATION

DISSOLUTION






