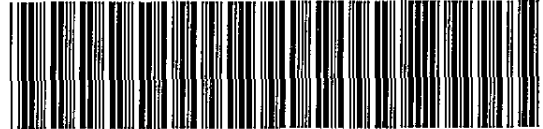

The undersigned for the purposes of forming a limited company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

Article I - Name

The name of the limited liability company shall be ACS AMERICAN CONCRETE SYSTEMS, L.L.C., (Company)

Article II - Address

The principal place of business of the Company in Florida shall be 391 Northwest Broken Oak Trail, Jensen Beach, FL 34957.

Article III B Effective Date

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

Article IV B Duration

Article IX B Termination of Existence

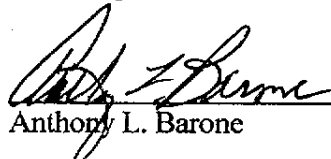

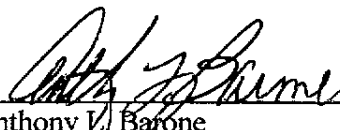
