

# ARTICLES OF CORRECTION to ARTICLES OF ORGANIZATION of DILAND II, LLC A Florida Limited Liability Company



PURSUANT to the provisions of Section 608.4115, Florida Statutes, the undersigned files, within thirty (30) business days, these Articles of Correction to Articles of Organization.

- 1. The date of filing of the Articles of Organization was September 3, 2003.
- 2. Article IX of the Articles of Organization incorrectly provided that the company shall be managed by the members when, in fact, the business affairs of the company are managed and will be managed by both member managers and non-member managers. Article IX is hereby corrected to provide:

### "ARTICLE IX MANAGEMENT

The company shall be managed by a manager or managers, duly appointed by the members, in accordance with regulations adopted by the members for the management of the business affairs of the company. A manger may be a member or a person or business entity who is not a member or a combination of member-managers and non member-managers. The regulations may contain any provisions for the regulation and management of the company not inconsistent with law or these articles of organization."

## ARTICLES OF ORGANIZATION OF DILAND II, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be Diland II, LLC, ("company").

#### **ARTICLE II - ADDRESS**

The mailing address and street address of the principal office of the company is 315 North Atlantic Avenue, Daytona Beach, FL 32118.

#### **ARTICLE III - DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date if specified. The company's existence shall be perpetual, unless the company is dissolved earlier as provided in these articles of organization or in the regulations.

#### ARTICLE IV - REGISTERED OFFICE AND AGENT

#### **ARTICLE V - CAPITAL CONTRIBUTIONS**

The members of the company shall initially contribute to the capital of the company the amount of \$100.00.

#### ARTICLE VI - ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members or as provided in the regulations. **ARTICLE VII - ADMISSION OF NEW MEMBERS** 

Except as set forth in the regulations, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on the terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

#### ARTICLE VIII -MEMBER'S RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by a majority vote of the remaining members.

#### **ARTICLE IX - MANAGEMENT**

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
