The undersigned, being authorized to execute and file these Articles, hereby certifies that:

**ARTICLE I — Name:**

The name of the Limited Liability Company is: INTEGRATED PHARMACY STRATEGIES, LLC

**ARTICLE II — Address:**

**Article VII— Member's Right to Continue Business**



**Article VIII – Limitation on Agency Authority of Members**

Pursuant to section 608.4235 of the Florida Limited Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member.


