ARTICLES OF ORGANIZATION OF BNC TECHNOLOGIES, LLC

The undersigned persons, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, hereby adopt the following Articles of Organization:

ARTICLE I

The name of the company (hereinafter referred to as the "Company") is: BNC TECHNOLOGIES, LLC.

The duration of the Company shall be thirty (30) years.

The Company is formed for the following purposes:


- 1. To develop, market, lease, sell, or manage technology.


The effective date of this Company shall be August 29, 2003 (which date is not more than five business days from the actual filing of these Articles of Organization with the Secretary of the State of Florida).
