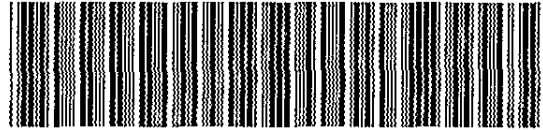

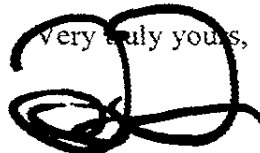

**ARTICLE IV -- REGISTERED OFFICE AND AGENT**

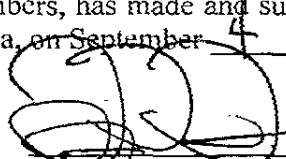

**ARTICLE V -- COMPANY TO BE MANAGED BY MEMBER(S)**

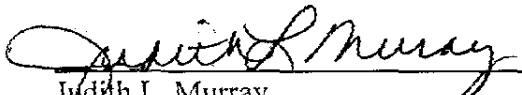
