



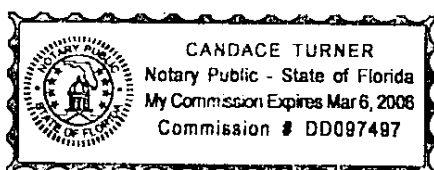
1. Marcos O. Acevedo is the President of ACE RESULTS MORTGAGE, LLC, a Florida limited liability company, (hereinafter "Company").
2. That the Company was administratively dissolved by the Florida Department of State on 1 October 2004.
3. That the Company failed to file its 2004-2005 Annual Report or pay the 2004-2005 Annual Report filing fee within the time prescribed by Florida Statutes Chapter 608 because:


