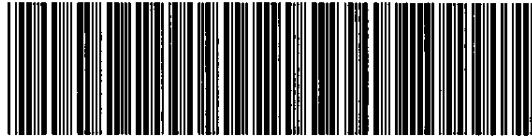

SECOND: The date of the adoption of these Articles of Dissolution is 18 December 2006.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members.
