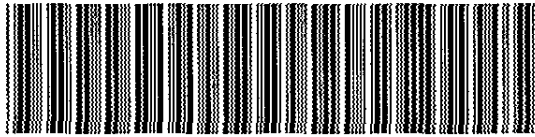

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name and street address of the registered agent of the company in the state of Florida are Clark Gerstner at 370 Lakeview Drive, Melbourne Florida, 32951.

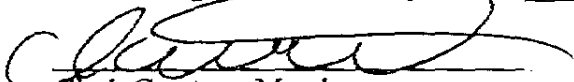
ARTICLE V -- MANAGEMENT

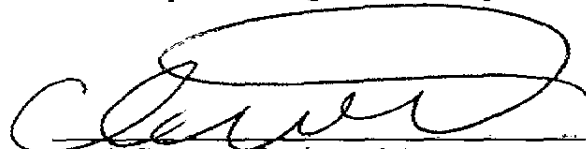
