

## ARTICLES OF ORGANIZATION **OF** PINEAPPLE CAY, L.L.C.

AND SERVICE OF THE SE The undersigned, for the purpose of forming a limited liability company under the Florid Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I - NAME
