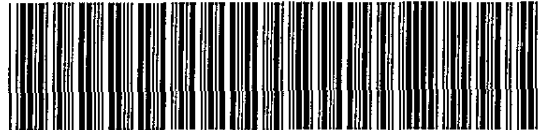



**ARTICLES OF ORGANIZATION

Additional Members


Additional members may be admitted upon the written consent of all other members.


