**ARTICLE I**

**NAME AND PRINCIPAL PLACE OF BUSINESS**

The name of this limited liability company shall be T-WYLIE HOLDINGS, LLC, and the mailing address of its principal office shall be P.O. Box 511197, Punta Gorda, Florida 33951-1197, and the street address of its principal office shall be 25188 E. Marion Avenue, Unit F-203, Punta Gorda, Florida 33950, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

**ARTICLE II**

**PURPOSES AND POWERS**

##### MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.


