ARTICLES OF ORGANIZATION OF RLT PUNTA GORDA, LLC



- 1. NAME. The name of this limited liability company is RLT PUNTA GORDA, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.
- 2. PLACE OF BUSINESS. The mailing address and street address of the Company's principal office is 3609 Madaca Lane, Tampa, Florida 33618.
- 3. REGISTERED AGENT AND OFFICE. The name of the initial registered agent of the Company is Preston O. Cockey, Jr. The street address of the initial registered agent of the Company is 201 North Franklin Street, Suite 2200, Tampa, Florida 33602.
