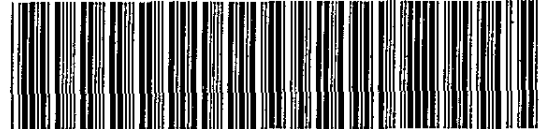

TO
ARTICLES OF ORGANIZATION
