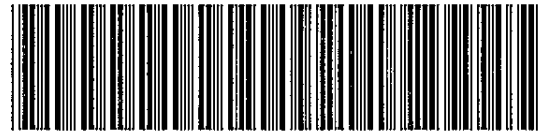

ARTICLES OF ORGANIZATION OF  
SAJU, MASSEY AND DUFFY, LLC (present name)**


**FIRST:** The Articles of Organization were filed on 09/09/2003 and assigned document number L03000034327. The entity's FEI number is 562405573.

**SECOND:** This amendment is submitted to amend the following:

**The name of this entity should be changed to "Saju, Massey & Duffy P.L.". This entity is a law firm.**

The purpose of this amendment is so that the individuals and group of individuals of Saju, Massey & Duffy may bring themselves and the limited liability company within the provisions of the PROFESSIONAL SERVICE CORPORATIONS AND LIMITED LIABILITY COMPANIES ACT (Chapter 621 of the Florida Statutes) by amending the articles of organization in such a manner so as to be consistent with all the provisions of this act and by affirmatively stating in the amended articles that the shareholders or members have elected to bring the corporation or limited liability company within the provisions of this act. Accordingly, the members of Saju, Massey & Duffy, LLC have elected to bring the limited liability company within the provisions of the PROFESSIONAL SERVICE CORPORATIONS AND LIMITED LIABILITY COMPANIES ACT (Chapter 621 of the Florida Statutes) and have elected to change the name of the entity to "Saju, Massey & Duffy, P.L."
