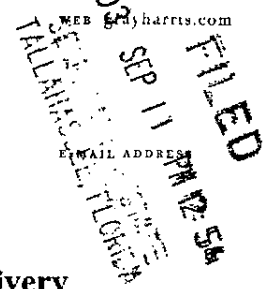


ARTICLE VI

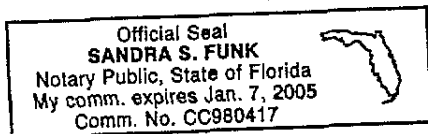




