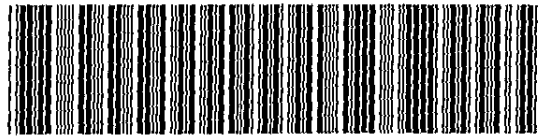

Florida Limited Liability Company**

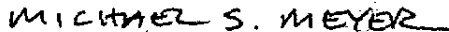
the Limited Liability Company. Any ownership interest held by Brenda L. Meyer and Michael S. Meyer shall be as joint tenants with right of survivorship.
