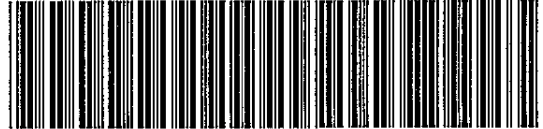

ARTICLE ONE
NAME


ARTICLE SEVEN
