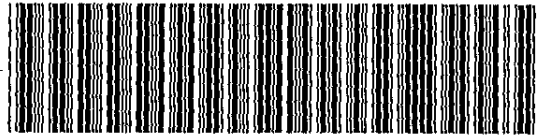

ARTICLES OF ORGANIZATION

FOR
