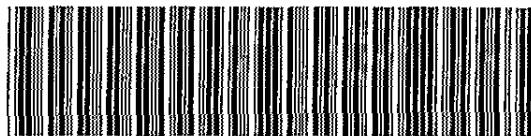

**ARTICLES OF ORGANIZATION  
OF  
ANSCA COMMUNITIES, L.L.C.**

The undersigned for the purpose of creating a limited liability company under the Florida Limited Liability Company Act (the "Act"), Chapter 608, Florida Statutes, hereby adopts the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company is **ANSCA COMMUNITIES, L.L.C.** (the "Company").

**ARTICLE II - DURATION**

This Company shall commence its existence upon filing and shall exist perpetually thereafter unless sooner dissolved according to law.

**ARTICLE III - INITIAL PRINCIPAL OFFICE AND REGISTERED AGENT**

The mailing address and street address of the initial principal office of the Company is **3333 S. Congress Avenue, Suite 401, Delray Beach, Florida 33445**. The initial registered agent for the Company at that address is **Charles Scardina**.

**ARTICLE IV - ADDITIONAL MEMBERS**

No person may be admitted as a Member unless each existing Member consents in writing to the admission of the additional Member.

**ARTICLE V - RIGHT TO CONTINUE BUSINESS**

The remaining Members Company may continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member of the Company.

## ARTICLE VI - MANAGEMENT

The business and affairs of the Company shall be managed under the direction of the Managing Member, who may exercise all powers of the Company and perform or authorize the performance of all lawful acts which are not by the Act or the Regulations adopted by the Company directed or required to be exercised or performed by the Members. This Company shall have at least one Managing Member initially with the exact number of Managing members to be specified by the Members from time to time unless the Members shall by a majority vote, determine that the Company be managed solely by the Members. The name and address of the initial Member and Managing Member is **Charles Scardina, 3333 S. Congress Avenue, Suite 401, Delray Beach, Florida 33445**. The initial Managing Member shall serve until the first annual meeting of the Members or until his successors are elected and qualify.

## ARTICLE VII - INDEMNIFICATION

The Company shall indemnify and hold harmless any Managing Member or any former Managing Member, to the fullest extent permitted by law either now existing or hereafter enacted from and against any and all claims and demands whatsoever.

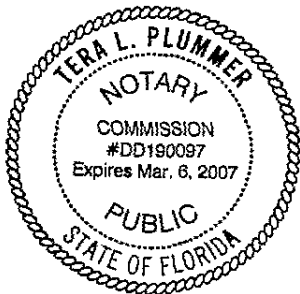
