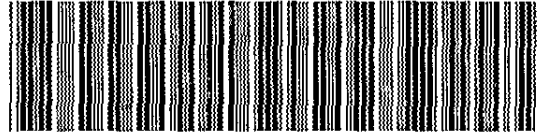



**ARTICLES OF ORGANIZATION
OF
COURTYARD INVESTMENTS, LLC**

The undersigned hereby forms and establishes a limited liability company under the laws of the State of Florida.

ARTICLE I

The name of this limited liability company is COURTYARD INVESTMENTS, LLC ("Company").
