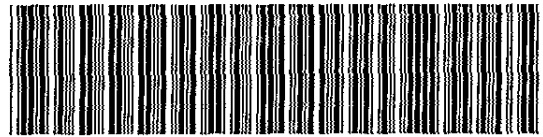


ARTICLE IV - MANAGEMENT BY MANAGERS
