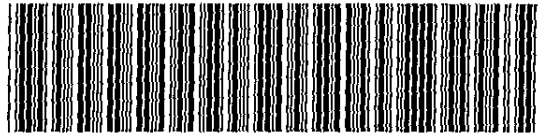



A LIMITED LIABILITY COMPANY


1. **Name.** The name of the limited liability company is Olde Town Brokers-Winter Park, L.L.C..


