**RESOLVED**, that the Company shall dissolve its corporate existence effective upon filing Articles of Dissolution with the Florida Secretary of State.


**RESOLVED**, that the sole member or any officer of the Company shall file the Articles of Dissolution and any terminations of certificates of authority with the appropriate governing authorities.
