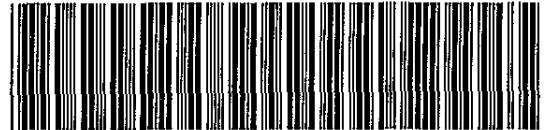



Article I. Name and Principal Place of Business is hereby amended to read as follows:




