I was recently notified by email from your agency that an amendment was filed for my business. See attachment A.


This amendment was fraudulent. I do not know this person and obviously never gave permission for him to change my status with your department.



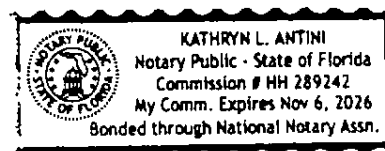
