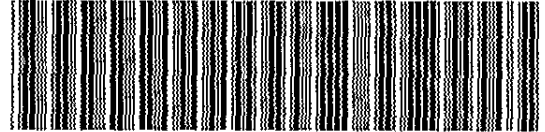

The street address of the initial registered office of the Company is 1715 West Cleveland Street, Tampa, Florida 33606, and the name of the initial registered agent of

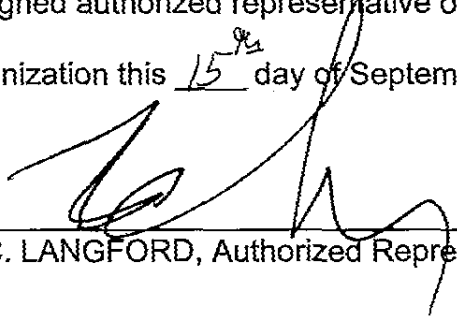
the Company at that address is E. C. Langford.

The Company is to be managed by one or more managers and is, therefore, a manager-managed company.

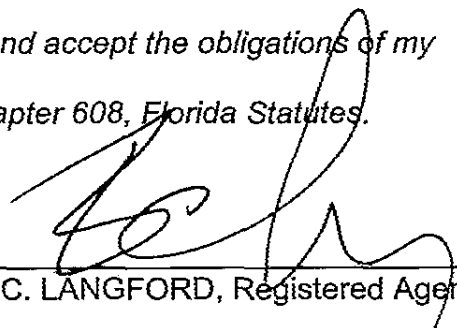
