The name of the limited liability company shall be Genco Travel, LLC, ("company").

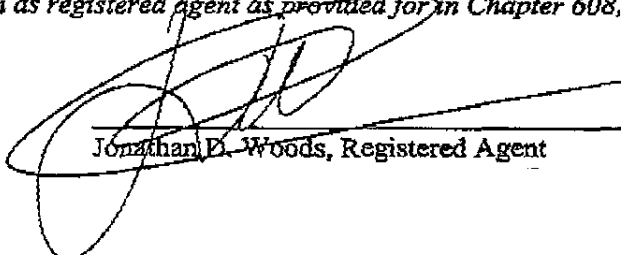

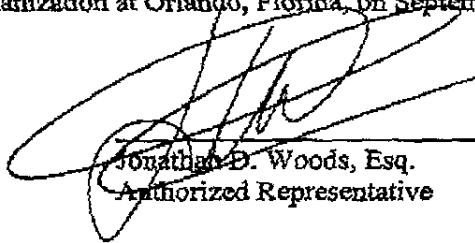
ARTICLE IV - MANAGEMENT
