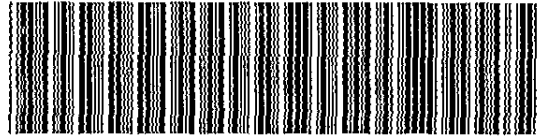



ARTICLE IX - CAPITAL CONTRIBUTIONS


