

## ARTICLES OF AMENDMENT OF BRIDGEGAP SYSTEMS, LLC

**THE UNDERSIGNED,** WILLIAM K. LOVELACE, being the authorized representative of the Members of BRIDGEGAP SYSTEMS, LLC, does hereby certify that the following Amendment to the Articles of Organization of BRIDGEGAP SYSTEMS, LLC was approved by the Members of said Corporation on the 18th day of December, 2003, at a duly called meeting of the Members.

The Articles of Organization of BRIDGEGAP SYSTEMS, LLC are hereby amended as follows:

1. Articles VI, VII, VIII and X are hereby deleted and the following inserted in lieu thereof:

#### ARTICLE VII ADMISSION OF NEW MEMBERS

The members shall not have the right to admit new members to the Company. New members may come into the Company only upon the agreement of those members owning at least seventy-five percent (75%) of the interest in the Company and upon such terms and conditions as the existing members may unanimously agree.

# ARTICLE VIII CAPITAL CONTRIBUTIONS, PROFIT/LOSS ALLOCATION AND MEMBER VOTING

A. <u>Initial Contributions.</u> The total amount of cash or property to be initially contributed by each of the initial members of the Company is as follows:

- B. <u>Profit/Loss Allocation</u>. The profits and losses of the Company shall be allocated among the members in accordance with the Regulations of the Company.
- C. <u>Member Voting.</u> All members of the Company shall be entitled to vote on matters relating to the Company. Each Member's vote shall be weighted in accordance with the Regulations of the Company.
- D. <u>Additional Contributions</u>. The Members shall make additional capital contributions from time to time, as required by the Regulations adopted by the Company.

### ARTICLE X AMENDMENT OF ARTICLES OF ORGANIZATION

These Articles may be amended at any time by a resolution adopted by a seventy-five percent (75%) vote of the members at any annual or special meeting, provided at least ten (10) days written notice is given to each member of the time and place of the meeting and the purpose thereof.
