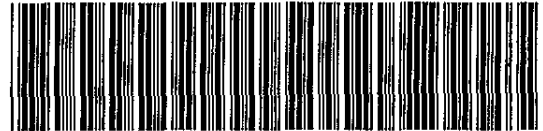



8.2 Equipment Financing


