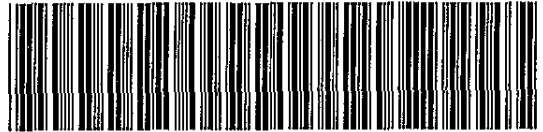

Article IV. Management. Edith Claro Rodriguez and Patricio Salazar are no longer Managers/Director of the Company.


