

ARTICLES OF ORGANIZATION OF squishyWorks, LLC A FLORIDA LIMITED LIABILITY COMPANY

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "squishyWorks, LLC."

ARTICLE II - Address

The mailing address and street address of the principal office of the Company is 719 Morningstar Lane, Hernando, Florida 34442.

ARTICLE III - Duration

The period of duration for the Company shall be perpetual.

ARTICLE IV - DESIGNATION OF REGISTERED AGENT INITIAL ADDRESS OF REGISTERED OFFICE
