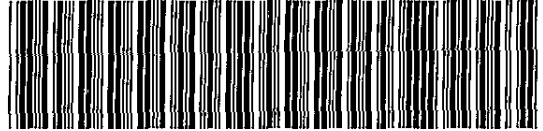

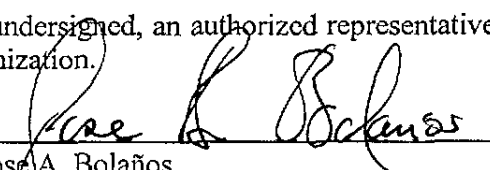
Article IV. Duration

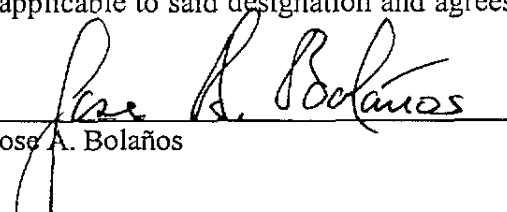
