ARTICLES OF ORGANIZATION

OF

BAREFOOT CHARTER INDUSTRIES, LLC

ANS EN ON PROPERTY OF THE PARTY The undersigned persons hereby adopt these Articles of Organization in order form a limited liability company under Chapter 608 of the Florida Statutes.

ARTICLE I - NAME

The name of this limited liability company shall be BAREFOOT CHARTER INDUSTRIES, LLC (the "Company").

<u>ARTICLE II – DURATION</u>
