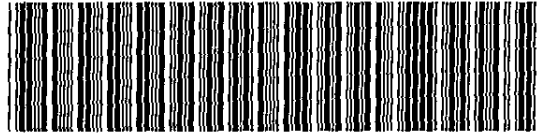


## **ARTICLES VI. RIGHT TO CONTINUE BUSINESS**
