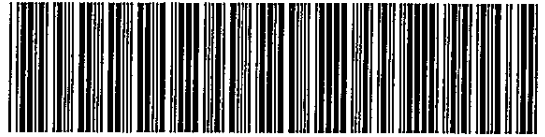





**ARTICLES OF ORGANIZATION
FOR
BUSINESS WITHOUT BOARDERS GROUP, LLC**

ARTICLE 1 - Name. The name of the limited liability company shall be BUSINESS WITHOUT BOARDERS GROUP, LLC.

ARTICLE 2 - Mailing Address and Principal Office Address. The mailing address and principal office of the limited liability company shall be 5413 Lake Margaret Drive, Suite B, Orlando, Florida 32812.




