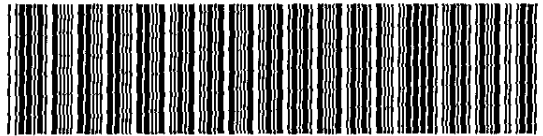

### **Admission of Additional Members**




