## ARTICLES OF ORGANIZATION

### OF

AMAZING HEALTH, L.L.C.

#### ARTICLE I

Name. The name of the limited liability company ("Company") is AMAZING HEALTH, L.L.C.

#### ARTICLE II

Address. The mailing and street address of the Company's principal office is: 2385 S.W. Estella Terrace, Palm City, Florida, 34990.

#### ARTICLE III

Duration. The period of duration for the Company is perpetual beginning on the date these Articles of Organization are filed by the Florida Department of State.

#### ARTICLE IV

Nature of Company. The general nature of the business to be transacted by the Company under these Articles of Organization shall be to engage in the sale and distribution of health and nutritional products, to provide counseling services related to health and nutritional products, and to engage in any other activity or business permitted under the laws of the United States and of the State of Florida, and to carry out said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

#### ARTICLE V

Management. The Company is to be managed by its members.

#### ARTICLE VI

Admission of New Members. Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.

#### ARTICLE VII

Continuation of Business. The remaining members of the Company have the right to continue the business of the Company on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business of the Company may be continued only on the written consent of a majority of the remaining members.

#### ARTICLE VIII

Amendment of Articles. These Articles of Organization may be amended in the manner provided by law. Every proposed amendment to these Articles of Organization shall require the approval of the managing member, whereupon it shall be proposed to all the members, and, for adoption, shall require the approval at a member's meeting of a majority of the members entitled to vote thereon; alternatively, all of the members may sign a written statement adopting the proposed Amendment to these Articles of Organization.

#### ARTICLE IX

Operating Agreement. The Operating Agreement of the Company shall be made, altered or rescinded by a majority vote of the members of the Company at a meeting of the members; alternatively, all of the members may sign a written statement adopting the proposed Operating Agreement or changes thereto.

#### ARTICLE X

Registered Agent and Office. The name of Company's initial registered agent in Florida is Reina Ramos. The address of Company's registered office in Florida is 2385 S.W. Estella Terrace, Palm City, Florida, 34990.
