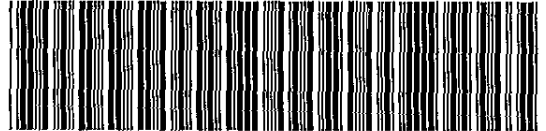

ARTICLES OF AMENDMENT OF ARTICLES OF ORGANIZATION

WHEREAS, pursuant to Article I of Articles of Organization filed with the Secretary of State on the 24th day of September, 2003, Florida limited liability company document number L03000036312 was issued in the name of KELLER WILLIAMS GULF COAST REALTY TYRONE, LLC, a Florida limited liability company (the "Company"); and
