**ARTICLES OF ORGANIZATION
OF
EC PORT RICHEY, LLC**

The undersigned hereby executes these Articles of Organization ("Articles") for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE I

Name

The name of this limited liability company (the "Company") shall be:

EC Port Richey, LLC

ARTICLE II

Principal Office and Mailing Address

The address of the principal office of the Company shall be:

ARTICLE III

Registered Office and Registered Agent

The initial registered office of the Company shall be located at 101 E. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles of Organization in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.
