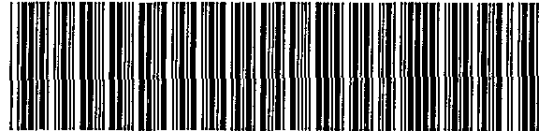

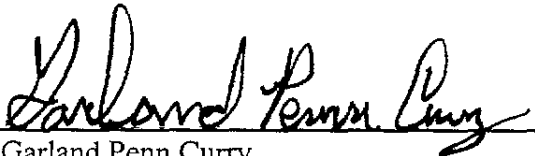
1. Name. The name of the limited liability company is GPC, LLC.

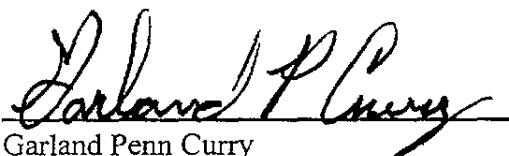
