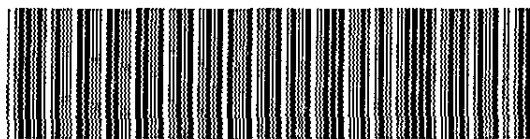

The Company shall be a member managed Company.


ARTICLE VIII

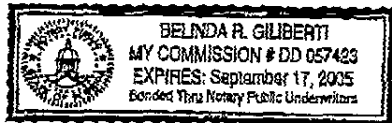


