

ARTICLES OF ORGANIZATION OF FLIGHTLINE AVIATION APPAREL, LLC

The undersigned, for the purpose of forming a limited liability companyounder the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited company shall be Flightline Aviation Appared LLC. ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be c/o Daniel Feinstein, 13790 NW 4th Street, Suite 106, Sunrise, Florida 33325.

ARTICLE III - DURATION

The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members, provided there are at least two remaining members.

ARTICLE IX - MANAGEMENT
