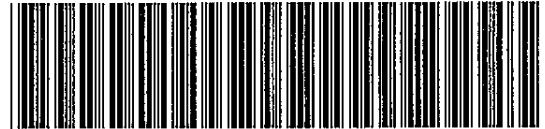

# ARTICLES OF ORGANIZATION OF FLIGHTLINE AVIATION APPAREL, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes acknowledges, and files the following Articles of Organization.

## ARTICLE I - NAME

The name of the limited company shall be Flightline Aviation Apparel, LLC. ("Company").

## ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be c/o Daniel Feinstein, 13790 NW 4th Street, Suite 106, Sunrise, Florida 33325.

## ARTICLE III - DURATION

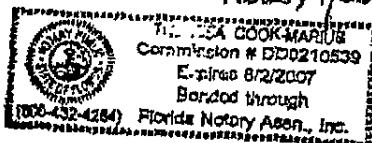
